

SECTION II

WHEREAS the Company is a not-for -profit organization dedicated to helping people wo are tattooed, scarred, burned and, or branded from negative experiences and to transform such marks into artwork or remove them through laser treatment.

And

WHEREAS Participant has a mark on their body they wish to transform into art or remove NOW THEREFORE, the Parties agree as follows:

- Participant grants Company the absolute and irrevocable right in respect to the ARTWORK and the image of the skin on which the ARTWORK lies, to use, re-use, publish, and republish the same in whole or in part, in any media now known or hereafter devised, for publicity, educational resources, marketing material, documentaries, or for any other means COMPANY sees fit, subject to PPARTICIPANT'S choice as outlined below in Section III.
- 2. PARTICIPANT agrees to one of the following three choices regarding COMPANY'S use of the ARTWORK and skin as outlined in Section 2 above. PARTICIPANT has indicated their choice by initialing either choice A, B, or C in the following:

SECTION IV

PARTICIPANT voluntarily assumes any and all risks, known or unknow, associated with the participation of the process, including but not limited to the risk of physical, mental and/or emotional injury, minor and/or severe bodily harm, and /or illness, which may arise by any means, including but not limited to act, omissions, recommendations or advice by either COMPANY or AGENTS

SECTION V

PARTICIPANT voluntarily and knowingly releases, discharges, or relinquishes any and all claims, actions, and lawsuits of any kind against COMPANY related to or arising from the participation in the process of TRANSFOMATION

SECTION VI

PARTIES agree that COMPANY and PARTICIPANT shall work together in determining ARTWORK design. PARTICIPANT holds final authorization of ARTWORK to be used in TRANSFORMATION

SECTION VII

PARTIES agree that COMPANY owns any copy write associated with completed TRASFORMATION and ARTWORK. PARTICIPANT understands that for purposes of copywrite that the TRANSFORMATION AND ARTWORK are not a joint work and is not intended to be a joint work by either PARTICIPANT or COMPANY

SECTION VIII

PARTICIPANT represents and warrants to COMPANY that PARTICIPANT

- (A) has carefully read this AGREEMENT and understands its contents;
- (B) is not a minor;
- (C) is of sound mind and body;
- (D) possesses all rights and faculties to execute this AGREEGMENT; and
- (E) understands that this AGREEMENT includes a waiver and release of liability of COMPANY by PARTICIPANT. PARTICIPANT acknowledges and agree COMPANY is relying on the AGREEMENT in allowing PARTICIPANT to participate in the process.

SECTION IX

Notwithstanding any provision of this AGREEMENT to the contrary, neither Company or AGENT(S) shall be liable to PARTICIPANT PARTIES for any indirect, special, incidental, consequential, punitive, or exemplary damages, whether in an action or contract or tort, under statute or otherwise, arising from any claim directly or indirectly relating to or arising in connection with the process of TRANSFORMATION or this AGREEMENT.

If any provision in this AGREEMENT is found invalid, unlawful, or unenforceable to any extent, such provision shall be excluded from this AGREEMENT, the remainder of which shall continue to be valid, lawful and enforceable in all other respects to the fullest extent permitted by law.

SECTION XI

PARTICIPANT acknowledges that any other waivers signed by PARTICIPANT in connection with the process of TRANSFORMATION are incorporated into this AGREEMENT, including but not limited to any waivers PARTICIPANT signs with any ARTIST.

Subject to SECTION XI above, this AGREEMENT constitutes the entire understanding among COMPANY and PARTICIPAT with respect to the subject matter hereof and supersede all prior AGREEMENTS, promises, proposals, representations, understandings, and negotiations

whether written or oral, among COMPANY and PARTICIAPNT with respect to such subject matter. No amendment, supplement or modification to this AGREEMENT shall be binding unless made into writing and signed by the PARTIES hereto.
